A safe place for children and youth.

Toba Centre for Children & Youth (Toba Centre) is a charitable organization that coordinates a collaborative approach to child abuse investigation and response. We integrate a multidisciplinary community of professionals—law enforcement, medical, child welfare, mental health, Toba Centre staff and volunteers, and other professionals involved in the response to child abuse—in a child-centred environment to work together in order to restore the health and well-being of those affected by child abuse.

Over the past 12 years, Toba Centre (formerly Snowflake Place) has evolved and expanded from primarily providing forensic interviews in a child-friendly space to providing the wrap-around supports characteristic of the internationally recognized child advocacy centre model, using evidence-based and evidence-informed practices.



Here at Toba Centre, before I'm ever seeing a child or family, they've actually had a forensic interview by someone who is highly trained to be doing that. So, instead of me walking in and saying, 'What happened,' before I see them, I'm talking to one of the forensic interviewers saying, 'What did they disclose?' Then, when I walk in the room with the kid, I can say, 'Tell me a little bit about yourself. What do you like doing? How are you feeling right now? Are there any questions you want me to answer today?' I don't even have to ask them about the worst thing that's ever happened to them. And that's really trauma-informed care. And that's what we're able to provide here that we never have been able to provide at the hospital or other settings. And for me, that's the true magic of this place; being able to focus on the kid and not focus on

On behalf of the Board of Directors, staff, and volunteers at Toba Centre, we are pleased to present our 2024/25 annual report. As we look back on the past year, we are filled with hope for children and youth impacted by abuse, pride for the team of dedicated professionals working together, and gratitude for the community that surrounds us, believing in our mission, getting involved, and supporting our important work.

The past year has been one of continued growth, meaningful collaboration, and unwavering commitment.

It was our first full year in our new facility with our multidisciplinary team (MDT) working together to investigate abuse, hold offenders accountable, and, most importantly, help children and families heal from abuse. families doing ok and having somewhere to turn for support when they need it. We are incredibly grateful to our partners for their ongoing commitment to making Toba Centre the centre of excellence we set out to be.

Our innovative service delivery model places children, youth, and families at the centre to provide coordinated, wraparound support from our MDT—police, child protection, medical, mental health, and Toba Centre staff and volunteers. We are proud of this team of dedicated, hardworking, and specialized professionals, who remain committed to their individual mandates while also finding new ways for collaboration in order to prioritize the health and wellbeing of children and youth. This is critical work, it is difficult work, and this team is up to the challenge.

Our community continues to come together in big ways in support of this important work and of the children and families of Manitoba. Our fourth annual Golf FUNdraiser, presented by Bockstael Construction, raised an incredible \$230,000 to support critical programs and services. In recognition of Child Abuse Awareness Month, we rallied our community to join our team, bringing awareness to the issue of child abuse and

Hearing, helping, and healing.

834 new referrals 14.8% increase in referrals over the prior year

At Toba Centre, the collaborative multidisciplinary response begins when new referrals are presented at our joint intake table. This daily meeting includes representatives from law enforcement, child protection, medical professionals, and Toba Centre staff. In 2024/25, 834 referrals involving 1,271 children/youth were presented at the joint intake table.

"[CACs] are founded on a shared belief that child abuse is a multifaceted community problem and no single agency, individual, or discipline has the necessary knowledge, skills, or resources to serve the needs of all children and their families. The CAC's coordinated and comprehensive response is also

guided by a shared philosophy that the combined expertise of professionals across disciplines results in a more complete understanding of case issues and better provides help, support, and protection to children and families as they pursue healing and justice."1

The multidisciplinary team (MDT) is the foundation of the CAC model and the overall effectiveness of the model is dependent on strong, collaborative work by a highly specialized and resilient MDT.2




At the time of each child's/youth's appointment, members of the multidisciplinary team meet to ensure all partners have the information they need to make informed decisions in their respective disciplines. During the 2024/25 fiscal year, 82.3% of multidisciplinary team meetings included representation from law enforcement, child welfare, and Toba Centre staff. The remaining meetings included representation from Toba Centre and either law enforcement or child welfare. Many meetings also included representation from medical (Child Protection Centre); however, this was not being tracked in 2024/25.

Note: In 2024/25 we observed a notable decrease in referrals from the Winnipeg Police Service (WPS) compared to the previous year. This change is partially the result of the WPS revising their referral process in January 2024 from referring all matters/occurrences received by the WPS CIU to the joint intake table, to identifying which matters/occurrences they would refer.

At this time, there is no referral criteria set in place for Toba Centre. Children who come to Toba Centre may not be representative of all reported cases of child abuse in Manitoba.

Every child/youth who attends Toba Centre receives services from our multidisciplinary team. When they attend Toba Centre, children/youth may participate in a forensic interview and/or receive medical care. Children/youth and/or their care providers may also meet with law enforcement, child welfare, and/or a case navigator during their time at our centre.



Forensic Interviews

The purpose of a forensic interview is to "facilitate information gathering from children to determine whether abuse occurred and, if so, the nature of the allegations, with the intention that this information will contribute to accurate and fair decision—making by the [multidisciplinary team] members relative to the criminal justice, child protection and relevant service delivery systems."³

These interviews are conducted in a manner that is developmentally and culturally sensitive, legally sound, and of a neutral, fact-finding nature.

Each referral to Toba Centre may involve one or more forensic interviews.

Medical Services

Providing medical services to children and youth involved in child abuse investigations is a standard component of the multidisciplinary team response. Toba Centre has two medical exam rooms where children and youth involved in child abuse investigations may receive medical exams. Throughout 2024/25, medical professionals from the Child Protection Centre provided on-site medical services in Toba Centre's two fully equipped medical exam rooms.

Case **Navigation**

Dedicated victim support and advocacy is provided through our Case Navigation Program. The objective of this program is to ensure the well-being and recovery of children who have experienced abuse or witnessed violence, and that of their caregivers, is prioritized by providing consistent and continuous support as they navigate both the systems involved in the response to child abuse and their individual journeys towards healing and justice. Our case navigators are integral to reducing trauma and promoting healing for children/ youth and caregivers and are often involved with a child or family beyond the involvement of mandated agencies.

Throughout our contact with Toba Centre, it has been helpful to feel the same care and support extended to the parent as the child. We are fraught with shame, grief, and a whole baffling array of warring emotions that take the back seat to our child. Being acknowledged and respected for our parental role and any of its shortcomings, to feel accepted for who I was and what I was going through; to feel validated, and for my emotions and trauma triggers to be validated; it was a missing balm that was so needed. This support was provided without judgement and allowed me to feel I had a safe space. Prior to accessing supports at Toba Centre, it felt like I was fighting for my child alone and without being seen."

Mental Health

In 2024/25, we added a dedicated Clinician and Mental Health Coordinator role to support the development of our mental health services. Several resources and supports for children and families referred to Toba Centre have been developed, including planning for the implementation of a trauma screening tool for children and youth, development and pilot of a caregiver support group, provision of brief counselling support to caregivers, and coordination of professional development and collaborative opportunities for community service providers working with families impacted by abuse.







Child abuse occurs irrespective of ethnicity and at Toba Centre, we see children from a variety of ethnic backgrounds.







TYPE OF ABUSE

In 78% of the interviews conducted at Toba Centre in 2024/25, children disclosed information indicating they were abused or had witnessed violence. For the remaining interviews, the children either did not disclose any information or did not fully participate in the interview process.

In November 2024, our four-legged colleagues, DWW Booster and DWW Duke, welcomed DWW Jelly to the Helping Hounds team.

They were excited to show her the ropes, and together they stayed busy greeting children and families, attending meetings, and comforting more than 300 children and youth during their appointments.

In addition to their work at Toba Centre, Toba's Helping Hounds also attended community events, representing our centre and helping to raise awareness about child abuse and the work we do. DWW Booster, DWW Duke, and DWW Jelly come from Dogs with Wings (DWW), an Alberta-based organization that has been changing lives since 1996. Dogs with Wings is accredited by Assistance Dogs International, ensuring the highest standards of training and service.





Diversity, Equity, and Access of Services

Guided by a Community Council with diverse knowledge and experience, Toba Centre aims to ensure our space and services are accessible and welcoming for all.

Throughout a child's and caregiver's involvement with Toba Centre, all multidisciplinary team members strive to provide trauma-informed, victim-centred, and culturally responsive support. Toba Centre staff seek to understand each child's and family's background, perceptions, and experiences, addressing any religious or cultural beliefs that may impact disclosure, needed services, and access to support. Planning/preparation, knowledge, and continued education assist the team in effectively understanding and responding to each child's and family's needs.

Our physical space offers an inclusive, equitable, and welcoming service delivery

environment. Every element, from the accessibility ramp and lift at the entrance, to the wayfinding marking on the carpet, to the water and fire features, and our Sacred Space fully ventilated for smudging, was carefully designed and embedded in our model.

Diversity, equity, and inclusion have always been priorities at Toba Centre. As part of our ongoing commitment to these priorities, in 2024/25, we began developing our Diversity, Equity, and Inclusion Strategy and Reconciliation Action Plan to guide our efforts over time. Throughout the year, we worked closely with Elder Billie Schibler who provided guidance and mentorship to Toba Centre leadership on cultural programming, gatherings, and ceremonies, with a particular focus on Indigenous culture.

Public Awareness

In late spring 2024, we built on the momentum of the previous fall's campaign and further increased awareness of our new child-centred environment, our coordinated multidisciplinary response to child abuse, and the importance of community in helping hurt children and families heal. Adam Lowry lent his profile with a powerful message encouraging Manitobans to rally around children and families impacted by child abuse, and 103.1 Virgin Radio's Ace Burpee Show used their voice to do the same.

The campaign included a 30-second television commercial and billboards/other out of home ads throughout the province, both featuring Adam Lowry. Social media and radio ads rounded out the campaign, along with a collaboration between the Ace Burpee Show and Jenna Rae Cakes for 'Toba Day' cupcakes that raised awareness and funds for Toba Centre.

Child abuse can occur in any community and affect anyone. For Child Abuse Awareness Month 2024, in addition to bringing awareness to the issue and rallying support for those impacted by abuse, we called on Manitobans to learn the signs of abuse, to know what to do if a child discloses or abuse is suspected, and to know how to report it.

We #GoBlueToba to honour the 1 in 3 Canadians impacted by some form of child abuse.

We #GoBlueToba to spark conversation and provide important education about child abuse to our communities

Also new this year, we worked with local jersey manufacturer, Keener Jerseys, to design custom #GoBlueToba hockey jerseys, which provided a common thread throughout our awareness activities for the month.




